Policy

WHEREAS, the Board of the Nyack Parking Authority from time to time adjusts parking policy to adapt to changing community conditions and needs, and the opening of a supermarket adjacent to the Riverspace parking lot has increased the need for short term parking that is maximally convenient for visitors to both the supermarket and nearby businesses;

WHEREAS: After thorough consideration of the various aspects of the problem and study of available data, has hereby determined that certain work, as described in its application and attachments, herein called the "Project", is desirable, is in the public interest, and is required in order to implement the Project; and

WHEREAS, The New York State Department of Transportation has made fund available from the Federal Highway Administration through the Transportation Alternatives Program to support bicycle, pedestrian, multi-use path projects and programs and expand opportunities for non-vehicular transportation choices; and

WHEREAS, the activities of the Project herein improve mobility, provide safe routes for for pedestrians to access daily needs, public transportation and recreational opportunities, enhance the character of the village and contribute to its revitalization, and further the Village of Nyack's plans for ADA-compliant sidewalks throughout the entire village; and

WHEREAS, the Village deems it to be in the public interest and benefit under these acts to authorize and direct Don Hammond, as Mayor of the Village of Nyack, New York, to file an application for funds to the New York State Department of Transportation, Transportation Alternatives Program.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Nyack:

- 1. That Don Hammond, as Mayor, is hereby authorized to file an application for funding in support of the construction of an ADA-compliant sidewalk system in the Village's historic waterfront and central business district in the area bounded by Cedar Hill Ave, Piermont Rd, Sixth Ave, and Highland Ave.
- 2. That the Municipality agrees that it will fund as a match at least 20% of the cost of the Project, and that funds will be available to initiate the Project's field work upon execution of a contract with New York State Department of Transportation.

5.5 Resolution No. 2023-163: Village of Nyack Board of Trustees Resolution Declaring Existence of Public Emergency Requiring Regulation of Residential Rents in Certain Housing Accommodations Opting In to NYS Emergency Tenant Protection Act (ETPA)

WHEREAS, §8623(a), of Chapter 5 entitled "Emergency Tenant Protection Act of Nineteen Seventy-Four", of Title 23, of the Unconsolidated Laws of the State of New York ("ETPA"), empowers a village to declare the existence of a public emergency requiring the regulation of residential rents for all, or any class (or classes) of, housing accommodations that are not exempt from the ETPA as per ETPA §8625 ("local housing emergency").

WHEREAS, as per ETPA §8623(a), the existence of a local housing emergency shall be a matter for local determination made by the local legislative body of the village on the basis of the supply of housing accommodations within the village, the condition of such accommodations and the need for regulating and controlling residential rents within the village; which declaration of a local housing

emergency may be made as to any class of housing accommodations if the vacancy rate for such class of housing accommodations, within such village, is not in excess of five percent (5%).

WHEREAS, at the request of the Village of Nyack Board of Trustees ("Board"), the Village Administrator of the Village of Nyack ("Village"), in May-June of 2023, conducted a vacancy survey/study of rental housing accommodations in buildings constructed, or substantially rehabilitated as residential units, prior to January 1, 1974, and which contain at least twenty-five (25) dwelling units or apartments ("vacancy survey/study"), which vacancy study/survey was accepted by the Board at its meeting of October 12, 2023, for the reasons, and findings, as documented and memorialized in the Board's Resolution #143 (which Resolution is incorporated by reference as if fully set forth herein), and which vacancy survey/study found a rental vacancy rate of 4.55%, for the aforesaid class of housing accommodations, which is less than 5%.

WHEREAS, the aforesaid rental vacancy rate of 4.55%, for the aforesaid class of housing accommodations within the Village, is less than the 5% vacancy rate established in ETPA §8623(a) as a basis for declaring a local housing emergency.

NOW, THEREFORE, BE IT RESOLVED by the Board, as follows:

- I. The Board declares that a local housing emergency exists, within the Village, as contemplated by ETPA §8623(a), and "opts in" to the ETPA.
- II. Effective upon adoption of this Resolution, the provisions of the ETPA shall apply to all buildings within the Village containing twenty-five (25), or more, rental dwelling units completed prior to January 1, 1974; except for those buildings described in the following paragraph "III."
- III. The provisions of the ETPA shall **NOT** apply to buildings within the Village:
 - (a). that fall within the exceptions set forth in ETPA §8625; or
 - (b). that are completely and entirely comprised of housing accommodations that constitute dwelling units that are subject to the Section 8 Housing Choice Voucher program through the U.S. Department of Housing and Urban Development (i.e., 100% Section 8 apartments), regardless of whether or not such buildings are privately owned and/or forprofit; or
 - (c). whose deeded owners have duly entered into a legally binding and enforceable agreement or contract with the Village, which shall "run with the land," and which agreement or contract addresses, by ameliorative means, the Village's local housing emergency in a manner that is satisfactory to the Board.

Public Comment -

Omar Yusef – The Israeli flags that were placed on Main St. are offensive. He feels that governments should remain neutral.

Amir Alamir – He agreed with the comments of Omar Yusef. He stated that his daughter experienced hatred (was called a terrorist) in Nyack Middle School.

Rabbi Ehrenreich – Thanked the Board for allowing the menorah placement in Hezekiah Easter Veterans Memorial Park on December 10th at 4pm.

Jack Dunnigan – The Village should approve the street fairs dates for both the Chamber and ACADA. There is a lot of prep work that needs to be done in the next few months.

Alex Vursta – He has a property on First Ave and he received a sidewalk violation. He did replace the sidewalk for a cost of about \$5,000 but the permit was \$1,200. He stated the fees don't make sense. He stated that he stands against rent control. The older buildings are the ones that need renovations and need the money.

Tristan Dunnigan – It is unfortunate that the street fairs dates were not approved tonight. Not everyone can be pleased with street fairs and improvements could be made but overall they are good events. Thanked the Board for supporting the Halloween Parade.

Charles and Kim Oleary – Owners of Crystals On the Rocks located on South Broadway. He asked if the public hearing on the 9th would be open to public comment to which the Mayor responded it was. He stated that they are in favor of all five street fairs and will attend the public hearing.

Joe Carlin – The scheduled 30 minute work session on November 9th is not enough time to discuss. If any changes are made to the street fair schedule it should be done in 2025.

Roger Cohen – Contracts for the street fairs need to be signed soon.

Carl Cameau – Stated that the street fairs should be updated and have more artists and crafts which will make Nyack even more of a destination.

Roger Cohen – The last street fair had 330 vendors and over 15,000 people attended so it is not accurate to say the street fairs have no appeal

Mark Brownstein – He has been a vendor at the street fairs and it takes time to make dramatic changes. Its not a decision that can be made after a short discussion.

John Gromada – He received a violation for his sidewalk. This can be a tremendous hardship for the homeowners and he feels bluestone sidewalks are a historic fabric of the character of the Village. He would like to work with the Village to save the bluestone sidewalks.

Ira Speigel – He is being sued by a person for slipping on their sidewalk. He doesn't feel that all bluestone sidewalks should be replaced and each sidewalk should be assessed on its own.

Katrina Hertzberg – Asked why sidewalk replacements have to be concrete and cannot be bluestone. She also asked if sidewalks are required.

Tyrone Azanedo – Street fairs benefit his business but agrees that they need changes. Overall, he wants what's best for Nyack. If street fairs are limited there should be other events.

Carl Cameau – There is a lot of empty commercial space in the Village and asked if the Board is doing anything to encourage new businesses.

Alex Vursta – He owns "Flights and Pints" and he has been hearing a lot of complaints about the homeless people in the Village. People are also complaining a lot about parking.

Tyrone Azanedo – Citizens and business owners have been chasing away the homeless people on their own. We need more things in the Village to bring shoppers in.

John Gromada – We need the commercial rents in town to decrease so new businesses come in.

Jack Dunnigan – The County holds the sales tax and then it trickles down to the municipalities but he doesn't feel that Nyack is getting enough.

Tyrone Azanedo – If street fairs are limited, the Chamber of Commerce won't be able to pay for other things like the Halloween Parade.

Orangetown Police – The Mayor asked OPD to continue doing their walkarounds. He also stated that there has been an uptick in panhandling on South Broadway and if residents/business owners have issues that they need to inform the police so they have the records.

Village Administrator – The Depew sidewalk project is about 80% completed. The Marina paving project is very close to being completed. The tree committee will be doing another cycle of tree planting. The water department is in need of a rate increase to cover costs. The water commission will be reviewing the percent increase at the November meeting.

Dear Honored Mayor and Honorable Trustees,

I hope this finds all of you in good health and spirits. I am writing to you concerning our proposal for the placement of a Menorah display in honor of Chanukah in Nyack's Hezekiah Easter - Veterans Memorial Park on Main Street.

We propose to set up an electric Menorah, as in past years, during the Chanukah Holiday of 2023. We would put the Menorah on or around December 3. The Menorah will stand for the duration of Chanukah (Chanukah is celebrated this year from December 7 – December 15) and will be removed during the following week. The menorah including the platform is approximately 9' tall and 5' feet wide. The placement and electricity will be coordinated with the Chamber of Commerce and be pulled as in past years from the gazebo in the park. Each night of the holiday, which begins on December 7th, one additional bulb would be turned on.

On Sunday afternoon, December 10th, at 4:00PM we will conduct the annual Menorah candle lighting ceremony. We would be honored to have you join the event as well.

This year, during the Menorah Lighting Ceremony, we are planning a Gelt-Drop, for which we are inviting the Fire Department to bring one of their Ladder Companies and 'drop' chocolate Chanukah 'gelt' for all to enjoy. For this we would need to reserve or block the bus layover lane on Cedar street from a half an hour before the event and for the duration of the event and perhaps close the street (Cedar from Main to Burd) to traffic while the Fire Dept is dropping the 'gelt'. Alternatively, we could possibly use the small lot for this purpose. We will work with the village administrator and the Police Dept and the Fire Dept to achieve the safest way of doing this.

Chanukah, the "Festival of Lights", is a celebration of a great miracle - the victory of a small, beleaguered Jewish nation over its powerful oppressors. In lighting the menorah, we rejoice in the triumph of freedom over tyranny, good over evil, right over might, and light over darkness. The menorah proclaims to all that through our dedication and devotion, the light of goodness and freedom can never be obscured, that darkness will ultimately be banished forever. With the current War in Israel this message is even more important than ever.

Looking forward to working with you to make this holiday season a most meaningful one for all of us.
