# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

### Total Trihalomethanes (TTHM) MCL Violation at Nyack Water System

Our water system recently violated a drinking water standard. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we did (are doing) to correct this situation. This notice to all Nyack Water Department customers in the Village of Nyack, South Nyack, Central and West Nyack area.

We routinely monitor for the presence of drinking water contaminants. Testing results from February 2023 through November 2023 show that our system exceeds the standard, or maximum contaminant level (MCL), for TTHM. The standard for TTHM is 80 ug/L. It is determined by averaging all the samples collected at each sampling location for the prior 12 months. The level of TTHM averaged at two of our system's sample locations for February 2023 through November 2023 were 87 ug/L and 81 ug/L respectively.

THM's, also known as a disinfection by-product, are general agreed to be the result of chlorine application (used to disinfect water against bacteria), organic matter in the source water and the time the water resides in the system or water age. Chlorine application is often increased during periods when algae blooms occur in the source water, in an effort to reduce taste and odor concerns. The Water Department is reviewing all its treatment processes and operational procedures to assess any impacts they might be having on the levels of THM's in our water. Water age in our system has generally been impacted by lessened demand (usage), and it is believed that this is partially related to the increase in the THM values. The Department has examined its flushing operations and is increasing those activities in an attempt to reduce water age across the system.

#### What should I do?

- There is nothing you need to do. You do not need to boil your water or take other corrective actions. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours.
- If you have a severely compromised immune system, have an infant, are pregnant, or are elderly, you may be at increased risk and should seek advice from your health care providers about drinking this water.

#### What does this mean?

This is not an emergency. If it had been an emergency, you would have been notified within 24 hours.

Trihalomethanes are disinfection byproducts formed during treatment of drinking water by chlorine, the most commonly used disinfectant in New York State. Drinking water is disinfected by public water suppliers to kill bacteria and viruses that could cause serious illnesses. For this reason, disinfection of drinking water by chlorination is beneficial to public health. The amount of trihalomethanes in drinking

water can change from day to day, depending on the temperature, the amount of organic material in the source water, the amount of chlorine added, and a variety of other factors. All public water systems that use chlorine as a disinfectant contain trihalomethanes to some degree.

The following paragraph summarizes and characterizes the available studies on human populations exposed to trihalomethanes, and provides a general summary of the health effects of trihalomethanes in animals, which occur at exposure levels much higher than exposures that could result through normal use of the water.

Some studies suggest that people who drank water containing trihalomethanes for long periods of time (e.g., 20 to 30 years) have an increased risk of certain health effects. These include an increased risk for cancer and for low birth weights, miscarriages and birth defects. The methods used by these studies could not rule out the role of other factors that could have resulted in the observed increased risks. In addition, other similar studies do not show an increased risk for these health effects. Therefore, the evidence from these studies is not strong enough to conclude that the observed increased risk for health effects is due to trihalomethanes, other disinfection by-products, or some other factor. Studies of laboratory animals show that some trihalomethanes can cause cancer and adverse reproductive and developmental effects after high levels of exposure. The risks for adverse health effects from trihalomethanes in drinking water are small compared to the risks for illness from drinking inadequately disinfected water.

## What is being done?

The Water Department has performed distribution system hydrant flushing in the affected area on April 19<sup>th</sup>, May 2<sup>nd</sup> and 24<sup>th</sup>, June 2<sup>nd</sup>, July 19<sup>th</sup>, September 20<sup>th</sup>, and on November 20<sup>th</sup> daily hydrant flushing began on Upland Drive, South Nyack. Also on July 19<sup>th</sup>, the College Tank was emptied of 100,000 gallons and refilled after a water main break. Contracted divers inspected and cleaned the Dickinson Avenue Reservoir from July 31 - August 3, 2023. A remote tank level monitor, data logger and pump controls were installed at the College Tank and South Highland Pump Station and put into service on Dec 1<sup>st</sup>, 2023. Additionally, as per New York State and County Health Department requirements, along with an engineering consultant, an operational evaluation has been performed focused on identifying root causes and providing recommendations for future operations to address the issue as related above.
